### Squirrel Nutkin

#### SQUIRREL NUTKIN TO GO INTO HIBERNATION ?

The lease on the property housing the Squirrel Nutkin shop and the Society,s headquarters runs out on November 27, and the owners will not renew it. For many weeks now the Co-op management have been searching for alternative premises, and many properties have been considered. Unfortunately, the Directors have been able to find nothing which they could put forward as a viable economic proposition for the shop.

In the better locations, where it would be possible to build up the level of trade, key money of several thousands of dollars is expected. Even in poorer locations, rentals expected amount to \$70 or more a week, compared to the \$15 per week paid now.

As an additional complication, Squirrel Nutkin Manager, Brigitta Jones, is leaving at the end of the year, and resigning as WANS Secretary. She will be greatly missed.

Interim arrangements are mentioned below. The Annual General Meeting of the Society and the Co-op will be held shortly, and we hope that members will be able to come up with some useful proposals. The time and date:

Squirrel Nutkin have the use of a workroom at the back of the shop until the end of the year. Christmas orders etc. will be dealt with from there. The phone number will remain unchanged this year.

Squirrel Nutkin has already arranged to take part in a special sale, called SCARBOROUGH FAIR, which will be held at the Belmont Racetrack in the week before Christmas (see West Australian for details). This operation will also be run from the shop workroom. The shop fittings may be sold or stored if no alternatives are found. Any suggestions or offers of help, please ring 381 8656.

The position with tree sales is still uncertain. Members involved in supplying trees may set up an alternative outlet next year.

The Co-op itself is <u>not</u> closing down. The Directors are looking at alternative trading methods (e.g. mail order or Christmas package sales or special sales from a caravan at shows etc.) which do not need a fixed base, if the Squirrel Nutkin shop has to go into hibernation. These activites could build up the Co-op's capital until a favourable opportunity occurs again for established trading.

#### MORE OF THE JOJOBAS

- a) planting trials in the Eastern Goldfields
- b) a talk in Floreat Forum

A letter has been received from P. Enever in Boulder from which we have extracted the more important points.

"About two years ago a fellow member of WANS kindly sent me about 50 seeds from which I got 90% germination. Some of these plants were put out last spring at Kalgoorlie Racecourse but hot weather and drought hit them before they could get established. This leads me to think that autumn planting might be more successful to avoid necessity of frequent watering to gain establishment.

A few plants went to Jack Wrigley at Kambalda Nurseries and were planted out in bushland. Subsequently Jack bought several kilogrammes of seed. Between us we have grown on about 1000 seedlings and seeded a further 2000, with batches going in fortnightly.

Recently 200 of my original seedlings, now about 20/30 cms, high, in 30 cm deep tubes which I made myself, went up to a friends property in the Gascoynes and about the same number out to a station on the Nullarbor. Smaller lots have gone to Manjimup and are being grown in local Goldfields gardens.

Kalgoorlie Town Council have been approached with a view to establishing an experimental plot and are presently debating the idea. Indications are that they will proceed with the scheme.

I shall not be setting any more seed until next spring as I find germination is at optimum once temperature reaches 25/30 degrees Celsius.

#### MACADAMIA NUTS ARE BECOMING A TOURIST ATTRACTION

The Sunshine Coast's latest tourist draw is pulling in the sight-seers at a cracking pace! The Macadamia nut processing and tourist complex at Woombye is connected through a walkway to the Sunshine Big Pineapple Plantation (CSR). The latter company set up this new complex in order to cater for the increased harvest of Macadamia nuts in Southern Queensland and New South Wales.

Operations manager, B. Adams, said 800 tonnes of Macadamias were being cracked annually, and the yields were expected to increase substantially over the next fifteen years.

Visitors can watch the process of cracking, sorting, cooking and packing inside a factory which is laid out along the lines of a Queensland colonial style building. There are also displays on the history and growing of Macadamia nuts. A shop sells the nuts as well as seedling trees.

#### WANS has become a member of the Australian Macadamia Society.

Members who wish to inform themselves about the activites of this particular society may approach the secretary for their News Bulletin which is distributed three to four times per annum. It consists of ten large typewritten pages, dealing with the various aspects of Macadamia culture.

Members in New South Wales may be interested to -now that the Macadamia Society functions in two bodies on account of the geographical distances involved. One group covers Southern Queensland, while the other concerns itself with the members living in northern New South Wales.
